Memorandum for Directorate of Host Nation Affairs

Subject: Supply Support Activity, Contract Number W52P1J-11-C-0019, Ashutosh Manpower Consultancy Services (“ASMACS”) Subcontract to General Dynamics Information Technology Contract Supporting US Army Contracting Command (ACC) at Camp Arifjan, Kuwait.

1. Purpose: Confirm validity of a U.S. Government contract supporting U.S. Forces in Kuwait.
2. The Contracting Officer for the Department of the Army, Rock Island Contracting Center (RICC), Rock Island, IL verifies the following information under a valid U.S. Contract.
 - a. General Dynamics Information Technology, Inc. (“GDIT”) has been awarded a contract (Contract # W52P1J-11-C-0019) to provide contractor personnel to provide support services to the US Army Department of Defense (DOD), US Federal Government Inter-Agency, Non-Governmental, and Coalition Forces in accordance with the AOR mission for DOD Supply and Warehouse Operations Support as approved by the Department of the Army at Camp Arifjan, Kuwait. Under this contract, a Subcontract has been awarded to Ashutosh Manpower Consultancy Services (“ASMACS”) by GDIT for One Thousand and Two Hundred (1,200) Third Country National (TCN) contractor personnel who will provide services on this contract.
 - b. The contract period of performance is December 30, 2010 through December 29, 2015, which includes a base year and four (4) option years. In addition, a final six (6) month extension may be exercised if/and as deemed necessary by the US Government.
 - c. For your information, Ashutosh Manpower Consultancy Services (ASMACS) will utilize ASMACS General Trading Company, WLL as their sponsoring agency. ASMACS General Trading Company, WLL will provide Ashutosh Manpower Consultancy Services (ASMACS) and ASMACS contractor personnel with sponsorship services (to include Residency Visa’s, Civil IDs, Kuwaiti Drivers Licenses) and housing accommodations, transportation, and other logistical support and services as required and requested for the One Thousand and Two Hundred (1,200) TCN contractor personnel.
